City-wide information Bootcamp for Domestic Energy Advice: Winter 2023/24

As we begin to enter the winter season, National Energy Action (NEA) believes energy advice is crucial amid the ongoing energy and cost-of-living crises. We want to help equip frontline domestic energy advisers and those supporting clients in fuel poverty with the necessary tools and most up-to-date information so they can offer effective support. This energy adviser bootcamp, run by the <u>NEA training and delivery teams</u>, has been designed to address the challenges and complexities of assisting those in need during the colder months and to give a refresher on the most salient points of advice delivery in the face of the energy and broader cost-of-living crises. This webinar also aims to provide knowledge on government-led measures and schemes for householders.

We'll also be devoting time to acknowledging that frontline advice delivery can be extremely challenging, and taking some time to look at mental health resilience and strategies around self-care over high stress periods.

VCSE temperature check survey

Following the last VCSE Partnership Programme Executive Group meeting, on 6th July, an Executive Group Action Plan has been developed based on points raised and questions asked during the meeting.

A key action that came from this meeting was the need to gather information relating to the following three areas:

- A VCSE Temperature Check Survey about Integrated Care Board (ICB) engagement with the VCSE sector.
- Cuts to the VCSE, including cuts to direct service provision and cuts to planned expansion.
- Funding, investment and commissioning at local level.

<u>This survey</u> is to collect information which we will share with the North East and North Cumbria Integrated Care Board (ICB) to strengthen our collective VCSE voice, so we can work together as an Integrated Care System (ICS) to address concerns and issues and raise awareness of areas of good practice that have the potential to be rolled out to other areas.

We appreciate that a lot of us are struggling with capacity at the moment, but the more people that fill in the survey, the stronger our collective voice will be.



Defibrillator funding for community spaces across England

The Department of Health and Social Care is inviting interested organisations to register expressions of interest for its £1 million Community Automated External Defibrillators Fund, aimed at increasing the number of AEDs in public places where they are most needed and to help save lives.

Please note that the fund will operate as follows:

a. 100 applications will be selected by DHSC to receive a fully funded AED - (funding is provided by DHSC and London Hearts)

b. 1900 applications will receive partial DHSC and London Hearts funding for an AED - organisations will be required to provide their own match funding on c. £750.

Who can apply: Be based in England

Not be an organisation that is eligible for Department of education scheme eg a school or academy.

To be eligible for a funded defibrillator you must also:

- Locate the secure defibrillator cabinet outside in an area that is accessible to members of the public 24 hours per day
- Be able to provide an electrical power source to ensure the defibrillator cabinet light and heater operate to keep the device at the right temperature
- Provide match funding for your application (c. £750) DHSC will select 100 applications that will be fully funded based on the areas most in need which will be announced in mid October.

Mackem Money

'Mackem Money' will award £130,000 in grants, agreed by a panel of residents from across Sunderland who have lived experience of the challenges faced by local communities.

The panel has prioritised funding for local groups that are:

• supporting inclusive communities

bringing people together, building social connections

• creating opportunities for healthier and happier people

play, physical activity, healthy food

• raising aspirations

building confidence and ambition, developing skills, encouraging achievement

Who can apply? The fund supports organisations, based and working in Sunderland, that have an income under £250,000, with priority for those under £100,000.

How much can we apply for? • For community and festive activities in 2023

£1,000 to £2,000: deadline for applications – 12 November 2023

• For projects in 2024

£2,000 to £5,000: deadline for applications – 22 December 2023

ABF The Soldiers' Charity Invites Applications for Final Round of 2023

ABF The Soldier's Charity provide grants to charities and organisations that provide lifetime support to soldiers, veterans and their immediate families when they are in need.

The funding is intended to support with projects and activities that directly benefit the Army community in six key areas: independent living, elderly care, education and employability, mental

fitness, families and housing. The grants can be used for a wide range of projects and activities from helping soldiers to adapt to life after service, to assisting elderly veterans maintain their independence.

Funding is at the discretion of the Grants Committee. The charity has not set a minimum or maximum amount. However, applications from organisations with which the charity has no established relationship are likely to be below £15,000.

Charities, not-for-profit organisations, CICs, community and housing associations which support the Army community can apply.

In the first instance, preference is given to charities and organisations which are to members of the Confederation of Service Charities (COBSEO) or Veterans Scotland.

There are usually three funding rounds per year.

The deadline for applications is 4 October for consideration in November 2023

Armed Forces Families Fund Early Years Programme Opens for UK Applications

On behalf of the Ministry of Defence's Armed Forces Families Fund Early Years Programme, the Armed Forces Covenant Fund Trust, is offering grants of between £5,000 and £80,000 for projects lasting up to two years.

Projects must clearly benefit Armed Forces families with a child under the age of 5 years by enhancing their access to high quality childcare. This could be done by, increasing the capacity in provision to meet an already known, or anticipated increase in demand, or to fund additional training and resources that will provide a clear benefit to children from Armed Forces families, who are aged 0-5 and not yet in school.

Applications will be accepted from:

- Early childhood education and childcare providers which operate either on Defence Estate (armed forces base, station unit or within the Patch) OR within 5 miles of where Armed forces families live or work.
- Local Authorities which wish to supply training to early childhood education and childcare providers who operate either on Defence Estate (armed forces base, station unit or within the Patch) OR within 5 miles of where Armed forces families live or work.
- An organisation, such as a registered charity, registered CIC, private limited company, which
 provides Childminder training for those working with Service Children near or on Defence
 Estate.

Funding for **projects on Defence Estates** is to be used to create/and or improve the outdoor learning environment; access specialist equipment/and or training; help to meet additional costs to enable more Armed Forces families to access childcare or general training to enable more to access qualifications to work with young children from Armed Forces families; including Send and SENCO training and resources.

Funding for projects **not on Defence Estates** can help meet additional costs to enable more Armed Forces families to access childcare; access specialist training or general training to enable more to

access qualifications to work with young children from Armed Forces families; including Send and SENCO training and resources.

There are two funding rounds.

The deadlines for applications are 5pm on 11 October 2023 and 12 January 2024.

Energy Saving Trust Foundation's Youth Climate Action Fund Open for UK Application

The Energy Saving Trust Foundation has launched the second round of its Youth Climate Action Fund and expanded it to include applications from Northern Ireland, Scotland, Wales, North East England and North West England. The first round focused on the West Midlands.

The Foundation is offering grants of up to £20,000 per year for up to two years (£40,000 in total) to a range of not-for-profit organisations with an income of less than £1 million and who are already working with children and young people experiencing inequality.

The funder is seeking to work with organisations to understand how young people who are experiencing inequality view the climate emergency and what issues are most important to them. This could include practical environmental projects, carbon reduction initiatives, education and awareness work, or advocacy and campaigning.

The funding can cover the following costs:

- Work that is currently underway and will continue into the grant funding period.
- Running costs, including overheads and energy costs.
- Staff costs.
- Equipment necessary to deliver the work.
- Training costs for staff, volunteers and children and young people.
- Venue hire.
- Travel costs.
- Other costs associated with removing barriers to access for children and young people.
- Volunteer expenses.
- Budget for young people-led project development.
- Small scale capital costs.

Up to 25% of the budget can go towards core costs or overheads.

There is a two-stage application process. Groups are encouraged to submit their expression of interest as soon as possible to allow sufficient time to complete the full application before the 27 October 2023 deadline.

The deadline to submit an Expression of Interest is 16 October 2023.

Linnean Society Accepting Applications for 'Our Local Nature' Grant Scheme

Linnean Society is offering grants of up to **£1,000 for community organisation**s linked with young people to deliver projects and activities that engage young people with local nature and natural spaces.

Through the Our Local Nature Grant Scheme, groups can deliver innovative projects that are designed and led by young people in the UK, that aim to increase access to local natural spaces and encourage a deeper appreciation and understanding of nature, such as:

- Running a school festival about nature.
- Painting community murals showcasing biodiversity in the area.
- Building or restoring a community garden.
- Creating a nature walk.
- Hiring a speaker to come and talk about local foraging.

Grants can be used for materials, room hire, publicity, speakers, trainers, freelancers, project-specific staff costs, audio-visual hire, reasonable volunteer expenses, transport, or other costs of activities/events.

The deadline for applications is 22 October 2023.

Background

The Society Foundation is an independent registered charity, funded and supported by the executive search firm Society. The majority of the Foundation's money comes in the form of an annual donation from Society, equal to at least 10% of the firm's net profits. Employees of the firm also undertake activities to support the Foundation's work, and to raise additional funds.

The Society's funding is in line with the following principles:

- They aim to work in partnership with the organisations it supports, setting mutually agreed goals with clear time scales.
- They aim to keep the grant application process 'light touch' and accessible.

- They try to foster a relationship of trust and honesty with the organisations they fund.
- They never commit to a project unless they are sure they have the funds to see it through.

Objectives of Fund

The funding is intended to support people from the following groups move toward paid employment:

- The recently homeless or vulnerably housed.
- Ex-offenders.
- Young people (16-24 years old) not in employment, education or training (NEET).

Value Notes A limited number of micro-grants of up to £2,500 are available each year.

Who Can Apply

Applications are accepted from the following:

- UK registered charities.
- Charitable Incorporated Organisations (CIO) or Scottish Charitable Incorporated Organisations (SCIO).
- Organisations with a governing document showing a clear charitable aim/purpose as defined by the Charity Commission for England and Wales.To be eligible, applicants must:
- Have a turnover under £500,000 per annum.
- Work with one or more of the following groups
 - The recently homeless or vulnerably housed.
 - Ex-offenders.
 - 16-24 years olds not in employment, education or training.
- Be able to show that they increase the employability of their beneficiaires.

Be able to supply at least one year of independently verified accounts

Family Hub Community Fund 23/25

Family Hubs and Start for Life

Sunderland is one of 75 local authorities in England to receive Government (DfE) funding to implement a package of family support and Start for Life services through Family Hubs. **This will cover:**

- Bespoke parent-infant mental health support.
- The creation of a network of Family Hubs, improving access to a wide range of integrated support services for families with children of all ages.
- Establish multicomponent breastfeeding support services in line with local needs.
- The funding of evidence-based parenting programmes.
- Clear 'Start for Life offer' and ensure that parents' and carers' voices are heard in the design, planning and delivery of services.

Family hubs are a way of joining up locally and bringing existing family help services together to improve access to services, connections between families, professionals, services, and providers, and putting relationships at the heart of family help. Family hubs bring together services for families with children of all ages (0-19) or up to 25 with special educational needs and disabilities (SEND), with a great Start for Life offer at their core.

The funding is to enable areas to take forward the recommendations in The Best Start for Life (a vision for the 1,001 critical days) review report and aligned to the local Best Start in Life Priorities.

Aims/priorities:

The priorities of Family Hub Community Funding is to build the capacity of the Voluntary, community and faith sector to support parents with 0-2 year olds facing challenges relating to the experiences and relationships with their developing baby, including:

- Reducing stigma around perinatal mental health.
- Reaching and empowering diverse communities with respect to culture, disability, gender and family structure.
- Inclusion of dads and co-parents.
- Increasing access through digital offers.
- Promote healthy parent-infant relationships, improve the emotional well-being of children, and contribute to improved school readiness.
- Build relationships with families to enable early identification of mental health issues and support accessibility to services.

We are looking within Sunderland for new or existing organisations who would like to connect into the existing and growing offer around Family Hubs via a one-off grant. The grant may enable existing groups to fill a gap such as expanding times or accessibility or reaching out to a wider range of care givers including foster carers, fathers, and co-parents.

Funding

Organisations can apply for projects of up to 6 months initially, followed by a second round of funding for 12 months, but must be able to demonstrate measurable outcomes by March 2025.

Who can apply? To be eligible to apply, an organisation must:

- Be a VCFSE organisation
- Be constituted/have a written set of rules that constitute what they do (governing document)
- Be based in Sunderland or currently delivering in Sunderland.
- Have or be developing experience of parental support and working with expectant parents or parents with children aged 0-2.

Grant amount: Groups can apply for:

- Round 1 a small grant between £1,000 £5,000
- Round 2 a small grant between £1,000 £10,000

Please note that funding should not be used to cover existing staffing costs. This funding is available for new activities that meet the objectives set out above.

Application process: Please consider your eligibility and commitment to the values and expectations of this grant scheme before making an application by carefully reading the guidance notes attached.

The Million Hours Fund Opens for Second Round

Funding for not-for-profit organisations, schools and local authorities to provide extra support to young people who are at risk of anti-social behaviour in eligible areas of England.

The Million Hours Fund is provided by the Department for Culture, Media and Sport (DCMS) and the National Lottery Community Fund (NLCF). This is the second of two rounds. The first round ran during the summer.

The Autumn round is offering grants of between £30,000 and £100,000 for projects that help create better outcomes for young people who may be at a higher risk of anti-social behaviour.

It will support extra hours of youth work that will help young people to have:

- Improved emotional wellbeing
- Improved life and practical skills
- Access to trusted relationships with adults and feel safer.

By 'youth work' is meant an activity that improves young people's well-being through education or leisure, supported by a voluntary relationship with a trusted adult. This can include detached youth work.

These extra hours could be used for learning, arts, playing sports, or developing life skills.

The funding is intended for projects that:

- Benefit young people aged 11 to 18, or up to 25 for young people with SEND
- Takes place in or benefits young people living in eligible local areas
- Effectively engage with young people at risk of anti-social behaviour
- Deliver extra youth work hours (not existing provision)
- Take place outside of school hours and are available on a regular basis
- Deliver youth work that is open access
- Demonstrate youth voice within the activities
- Are run by trusted adults, such as qualified youth workers, youth support workers or experienced volunteers.

The funding must be spent by 31 March 2026 and can be used to support:

- Staff salaries for delivery of this project
- Volunteer costs for delivery of this project
- Training costs
- Service delivery. For example, any direct costs associated with delivering the youth work provision such as materials, equipment, food.
- A share of the organisation's overheads. For example, any fixed costs to support the day to day running of their organisation, such as overall management, administration and support staff costs, venue hire, rent and utilities.

The deadline for applications is 24 November 2023 (12 noon).

Northern Gas Networks' Community Partnering Fund will support those living in or at risk of fuel poverty, promote energy efficiency and increase community resilience. The aim is to support those dealing with the aftermath of the pandemic and who are likely to be further affected by the energy and cost of living crises.

This may include, but is not limited to, promoting the Priority Services Register (PSR) – a free service provided by suppliers and network operators to support customers living in vulnerable situations and raising awareness of the dangers of carbon monoxide (CO) poisoning.

Grants of between £1,000 and £10,000 are available for organisations to raise awareness of and support their communities to:

- Support those living in or at risk of fuel poverty
- Promote energy efficiency advice and information
- Promote the Priority Services Register
- Raise awareness of the dangers, signs and symptoms of carbon monoxide (CO) poisoning

Eligibility

To be eligible to apply for a grant your organisation needs to meet all the following criteria:

- Meet the Community Foundation's eligibility criteria
- You are a volunteer-led group, a registered charity or a not-for-profit organisation with charitable aims
- You have a management committee, board of trustees or board of directors with at least 3 people who are not related or living at the same address and form a majority
- You have a separate bank account under the name of your group with at least two unrelated signatories or you have a charitable partner organisation willing to bank any grant awarded for your group (please get in touch if the latter case applies)
- You have a turnover of up to £500,000

We will prioritise projects that:

- Are run by local people, for local people your group needs to demonstrate good local links
- Can show a strong understanding of the needs of the community that will benefit
- Will have a direct impact on the community and local needs
- Are not one-off events and could become sustainable in the longer term
- Focus on supporting those who are vulnerable and/or face barriers to other services
