### UPDATE FROM ALLIANCE MANAGER TRACY HASSAN

An important part of our role is to help ensure the voices of the sector are heard. The Alliance takes part in a range of meetings with public, private and the voluntary sector to represent and give a voice to the voluntary and community sector across Sunderland . We do not aim to speak on behalf of voluntary, community and social enterprise (VCSE) organisations because we know we cannot possibly represent the independent interests of all the different organisations. Instead we work to support an environment in which our sector is heard and respected. We use our position to champion the role and value of VCSE organisations, and to challenge decisions which could be detrimental to them.

Featured below is a list of the meetings we have attended since our last e-bulletin.

#### North & Central Integrated Care Partnership

We were invited to attend the inaugural meeting of the North & Central Integrated Care Partnership.

The North and Central Partnerships have been merged to provide a more joined up approach for the work of the ICB across the region. It's important the VCSE sector are included in these discussions and we find a mechanism for feeding information into the Partnership. We have made contact with VONNE to look at how we increase our presence from across the region to ensure the VCSE sector are well represented. We will keep you updated with any future developments.

#### Health & Care Alliance

We were in attendance at the meeting in January.

A Links for Life (LFL) presentation was delivered explaining this is a system-wide approach to social prescribing, operating across the city. The Alliance is in the final stages of a Social Prescribing and Community Mapping research project which is funded by the ICB. Once the report is finalised it has been agreed the report and recommendations will be presented at the Health & Care Alliance.



### UPDATE FROM ALLIANCE MANAGER TRACY HASSAN

#### Low Carbon Shadow board

We attended the Low Carbon Shadow board as a Partner in October 2024. This is city-wide forum for discussion and development of Sunderland's approach to becoming carbon neutral. The Alliance gave an overview of how we as an organisation, and the sector, are looking at ways to feed into the City's Carbon Reduction Plan 2020-2030.

#### Real Living Wage Sunderland Action group

In January 2025 we attended the quarterly Real Living Wage Sunderland Action group. This group encourages Sunderland businesses and organisations to become Real Living Wage Employers. Moving forward we will be looking at engaging VCSE organisations based in Sunderland who are currently paying the real living wage and not yet accredited. Working with the Real Living Wage Foundation we are looking to support organisations through the process.

### CAPITAL GRANTS

Throughout 2024 we were asked to support capital funding applications and discovered there is limited funding available. Built on the evidence we have gathered identifying the needs of the sector we secured a UKSPF grant of just over £80,000.

Following the success of our Transport Grant opportunity we launched a capital grant offer to support renovations, repairs and refurbishments for community buildings.

We received 25 applications and awarded 13 grants worth £80k.

We must thank AGE UK and Sunderland Counselling Service for providing independent members of their teams to sit on the decision making panel.

It's been a positive process and organisations across the city are now in a position to improve their premises with works such as new flooring, damp proofing, roof and ceiling repairs, toilet blocks and painting and decorating.



### FUTURE FORWARD: COLLABORATION, CHANGE, AND GROWTH - A STEP TOWARDS STRONGER PARTNERSHIPS

In November, Sunderland Voluntary Sector Alliance (SVSA) hosted an online event titled *Future Forward: Collaboration, Change, and Growth.* 

The event aimed at strengthening collaboration across the sector by introducing a new collaborative matching service. This service will help organisations connect with compatible partners to work together on issues of joint interest, and receive support for joint bid writing. Additionally, the workshop explored strategies for diversifying income streams beyond traditional grants to ensure long-term financial resilience.

The event featured an impressive line up of guest speakers, including:

With 40 organisations in attendance from across the city, nearly half signed up for the new collaboration matching service. To tailor the service effectively, participants were invited to share insights on barriers to collaboration, past challenges in working in partnership, and their needs for effective partnerships. They also provided input on the types of resources, tools, or services that would help them tackle collaboration challenges.

The valuable feedback gathered will shape the future of the collaborative matching service. SVSA will keep those who signed up informed on the next steps in the coming months. Stay tuned for updates as we work together to foster stronger, more resilient partnerships within our sector!

### CASE STUDY-SUPPORTING SHINEY ROW BUSINESS ASSOCIATION

#### Background

In May 2024, SVSA received a support request from Shiney Row Business Association (SRBA) to assist with creating a formal constitution and establishing their organisational framework. SRBA's aim is to support local businesses in Shiney Row through collaboration, advocacy, and initiatives to drive economic growth.

#### Challenges

- Lack of Formal Structure: SRBA was operating informally and needed guidance on forming an unincorporated association.
- **No Constitution:** The group lacked a formal constitution, essential for defining its purpose, governance, and decision-making processes.

#### Interventions

- 1. Initial Contact: SVSA received a support request and arranged a Teams meeting to discuss SRBA's requirements.
- 2. **Provision of Resources:** Guidance and templates for creating an unincorporated association and a constitution were shared with SRBA.
- 3. **Draft Review:** During the meeting, the draft constitution was discussed, and SRBA agreed to develop a draft for review.
- 4. **Draft Submission and Feedback:** SRBA submitted the draft constitution, which was reviewed, amended, and returned with recommendations.
- 5. **Client Confirmation:** SRBA confirmed satisfaction with the amendments and planned to finalise the constitution, indicating no further support was required.

#### Outcomes

- Formal Constitution: Delivered a comprehensive constitution tailored to SRBA's needs, including:
- Purpose and objectives, such as fostering collaboration, advocating for businesses, and promoting local customer engagement.
- Governance framework and actionable strategies to support Shiney Row's business community.
- **Organisational Development:** Equipped SRBA with a foundational document to formalise their structure, enabling effective governance and future funding opportunities.
- Enhanced Client Capacity: Provided tools and templates to streamline SRBA's operations and ensure long-term sustainability.

#### Conclusion

SVSA's support empowered Shiney Row Business Association to establish a solid organisational framework, enabling them to pursue their mission of fostering a vibrant local business community. The collaborative process ensured the client could independently manage future initiatives while remaining connected to SVSA for ongoing support as needed.



### SOCIAL VALUE OFFER

#### **Opportunity for Sunderland Voluntary & Community Sector**

The Bloom Catalyst Fund is offering grants of up to £500 to help make local communities better places to live and work.

The Bloom Catalyst Fund recognises that it can sometimes be hard for community groups to raise funding to progress with community-based projects. They want to work with NEPO Member Authorities, of which Sunderland City Council is a member, to help support local community projects/programmes by offering support.

Bloom aims to maximise sustainability and social value in local communities, dedicating their time and resources to support causes that matter to the North East. Their mission is to become a catalyst for good, with a common goal of leaving a positive legacy for the benefit of everyone - helping their customers create meaningful local social value.

The types of programmes they would like to support are:

**Building safe communities** e.g. support for local youth groups, lighting for public spaces, private security, etc.

Supporting older, disabled, and vulnerable people e.g. befriending schemes, digital inclusion clubs, etc.

**Engaging people in health interventions & wellbeing initiatives** e.g. stop smoking, obesity, alcoholism, drugs, physical activities, etc

Tackling Homelessness e.g. supporting temporary housing schemes, etc Creating or managing green infrastructure e.g. increase biodiversity or to keep green spaces clean and deliver net zero, etc.

### NEWS ALERT: SKIPTON BUILDING SOCIETY CHARITABLE FOUNDATION TO REOPEN FOR APPLICATION ON 3 MARCH

After pausing applications last September, the Foundation has announced it is reopening its grants programme in March 2025 with two new focus areas through which it aims to drive social impact.

## The focus going forward will be to help people experiencing hardship and/or underserved groups within the UK to:

- Access a place to call home.
- Improve financial wellbeing.

For both focus areas, priority will be given to charities supporting people in the top 50% of the UK Index of Multiple Deprivation.

#### The Foundation is also making other changes:

- Only UK registered charities established for at least three years, with three or more trustees and whose work has direct benefit to people within the UK can apply.
- The maximum grant will rise from £6,000 to £10,000 this year.
- The Foundation will consider funding core costs, project costs, and small capital contributions that support its focus areas.
- Applications will be considered twice a year (in June and December) rather than quarterly.
- There will be two specific application windows (3 March to 1 May; 1 September to 31 October), outside of which applications will not be accepted.
- Unsuccessful applicants will no longer have to wait two years to reapply. They can reapply in one year. Successful applicants must wait three years.

The online application form will be available once applications open.

#### The first funding round will open for applications on 3 March and close on 1 May 2025.

### CITYWIDE AFFORDABLE FOOD CLUBS PROJECT

#### City Wide Affordable Food Clubs Project Closing date 28 February 2025 Background and Workshop details

Sunderland City Council and Feeding Britain are pleased to be working together to provide a more sustainable response to food crisis and food insecurity issues by encouraging the development of additional Affordable Food Clubs (AFC), that can be close to self-sustaining within 12 months.

An initial project led to funding being provided to two AFCs last Autumn. This new city-wide project aims to award 'set up' funding for at least one new or extended AFC project in each of the five local areas.

Given that this new AFC project is at city level the Council and Feeding Britain also believe that it would be better coordinated with an application headed by one lead organisation ,rather than an application from 5 separate organisations all operating completely independently. At a local level however the VCS organisations that are part of the application could still diversify and test different food delivery models – depending on their own local communities needs and existing food support offers.

To help facilitate this process the council will be holding two Microsoft Teams Workshop sessions for organisations interested in applying and especially for potential lead organisations on:

- 30 January 1-2 : being facilitated by the council
- 4 February 1-2 : being facilitated by the council and Feeding Britain
